ADMINISTRATIVE AGENDA SUMMARY

- a. Lee County –Redfish Point Channel Dredging is now complete. Normandy Channel, Chantry Canal, and Plato Canal Dredging Projects are all underway.
- b. Charlotte County-A Comprehensive Presentation of the county Regional Waterway Management System (RUMS) data base was conducted at the April 9th Charlotte County BOCC Meeting. MR., Listowski and Mr. Perrey provided staff support. Also, a contract was administered to install a lighted “H-Pile” to mark the entrance to Stump Pass, via request for assistance from county staff and commissioner Deutsch.
- c. Sarasota County –The Venice Marine Patrol office building was moved, as a safety measure, due to unstable and dangerously deteriorated shoreline/seawall foundation. The conditions have been stabilized and fortified. The Mayor of Venice requested historical documents related to Harbor Lights Mobile Home Park encroachment on the GIWW in Venice.
- d. Manatee County – In addition to the dredging project being conducted by the ACOE near Jewfish Key (Cut M-5) and longboat Pass entrance channel. WCIND staff has also collaborated with county staff on the final permit submittal for the Manatee River/Fort Hamer Dredge Project. Staff continues to pursue Federal authorizations through the Tampa ACOE office, and this process is challenging at best.
